Home Department – Criminal Case No.24/2021 of A.P. Fibernet Project Phase-1 under section 3 and section 10 (a) (b) of the Criminal Law Amendment Ordinance, 1944 (Ordinance No.38 of 1944)-Attachment of immovable properties – Ad-interim - Orders - Issued.

From the Additional Director General of Police, Crime Investigation Department, Andhra Pradesh, Mangalagiri C.No.135/EOW-II/CID-AP/2023, Dated:23.07.2023 & 07.09.2023.

ORDER:-

Whereas in the reference read above, the Additional Director General of Police, CID., Andhra Pradesh, Mangalagiri has stated that, this is a case of criminal misconduct by means of Cheating, Forgery, Forgery for the purpose of Cheating by using a forged document as a genuine one, designed criminal conspiracy, Criminal Breach of Trust by Public Servant in connivance with private persons, criminal intimidation and disobeying the law by framing an incorrect document with an intent to cause injury, wherein all the accused conspired and resorted to several irregularities in bagging and executing the AP Fibernet Project Phase-I and thereby caused wrongful pecuniary loss of Rs. 114,53,23,396/- to the Government Exchequer." This was registered on the report of the complainant Sri M. Madhusudhan Reddy, Managing Director, APSFL, Vijayawada on 09.09.2021 at 16.00 hours.

2. And whereas, the accused Sri Chandra Babu Naidu (A-25) conspired with the accused Vemuru Harikrishna Prasad (A1), Tummala Gopichand (A-11), Director of Tera Software Limited hatched up conspiracy and awarded AP Fibernet Project Phase-1 in favour of Tera Software Limited in a fraudulent manner by accepting false experience certificates, Though Tera Software Ltd was ineligible to participate in the Tender. While executing AP Fibernet Project Phase-I the accused in pursuance of their conspiracy violated the tender agreements and involved the companies of the accused Viplav Kumar V.L.S (A-20), Vijaykumar Rammurthy (A-21), Ramkumar Ramurthy (A22) and Kanumuri Koteswara Rao (A-23) with a malafide intention, utilized substandard materials and got released the funds to Tera software Ltd in a fraudulent manner without supply of goods and services and thereby caused misappropriation of Rs.114,53,23,396/- to the Government exchequer.

3. And whereas, the Additional Director General of Police, CID., Andhra Pradesh, Mangalagiri has requested that, kindly issue orders to attach the immovable properties i.e. (1) Residential plot in an extent of 797 Sq.yards in Document No.492/2018 of Sub-Registrar Office, Koritipadu, Guntur(Annexure-I), (2) Residential flat bearing No.503 in an extent of 48.35 Sq.Yds. in T.S.No.983 and Document No.8142/2019 of SRO, Visakhapatnam, Waltair Ward of Greater Visakhapatnam Municipal Corporation.

(Annexure-II), (3) Residential plot to an extent of 745 Sq. yards in Document.No.1022/2000 of Joint Sub-Registrar Office, Hyderabad South (Annexure-III), (4) Residential flat No. D in an extent of 1080 Sq.feet in Sai Sadan Building T.S. No.117/4 & 117/5 and Document. No. 893/06 of Joint SRO, Hyderabad South (Annexure-IV), (5) Residential flat No. B 1st Floor in an extent of 1080 Sq.feet in Sai Sadan Building T.S. No.117/4 & 117/5 and Document. No. 1299/06 of Joint SRO, Hyderabad South (Annexure-V), (6) Residential flat No. 101, 1st floor in an extent of 1607 Sq.feet in plot No. 16 in Sy. No. 1 and Document No.2446/2009 of Joint SRO, Hyderabad South (Annexure-VI) and (7) Agricultural land Ac 0-4.1322 Guntas in Sy. No. 210, 210P, 211 vide Document No.4300/2004 of SRO, Chevella, Ranga Reddy District (Annexure-VII), under the provisions of Criminal Law Amendment Ordinance, 1944 for preventing the disposal or concealment of the wrongful gain obtained by means of offence by the accused/accused companies, and to authorize the Investigating Officer for filing the same before the Hon'ble Court of Special Judge for SPE & ACB cases, Vijayawada, for taking further action into the case.

4. The Government after careful examination of the matter, hereby issue an ad-interim orders for attachment of immovable properties mentioned in the Annexures-I to VII duly authorizing the Additional Director General of Police, Crime Investigation Department, Andhra Pradesh, Mangalagiri being the competent authority, as defined in sections 3 and section 10(a)(b) of the Criminal Law Amendment Ordinance, 1944 (Ordinance No. 38 of 1944), is authorized to file an application before the Hon'ble Court concerned to make the orders absolute.

5. The Additional Director General of Police, Crime Investigation Department, Andhra Pradesh, Mangalagiri and Competent Authority is requested to take necessary further action in the matter as per the provisions of the said Ordinance made there under, duly following the due procedure and send compliance report to the Government.
