Occurred on 14.05.2021 at about 11.30 PM at CBCID Office, Medical College Road, Guntur and the same was reported in the P.S through E-Mail on 11.07.2024 at about 07.00 PM in which the Complainant Mr. K. Raghurama Krishnam Raju, S/o KVSSN Raju, aged about 62 Yrs, former Member of Parliament from Narsapuram, Andhra Pradesh stating that he was arrested in Cr No. 12/2021 by the CBCID Officers at Hyderabad. Then they not produced him before the local Magistrate in Hyderabad and not obtained transit arrest warrant and shifted him to CBCID Office, Guntur. Then Certain Police Officers i.e Mr. PV Sunil Kumar IPS, the then DG of CBCID along with Mr. Seetharamanjaneyulu IPS and other Police Subordinates came into CBCID Office and beat him with rubber belt and lathi and even not allowed to take medicines in respect of his heart ailment with the influence of Mr. Jagan Mohan Reddy, the then Chief Minister of A.P. They knowing pretty well that he has under gone a Bypass Surgery to heart, some persons sat on his chest applied pressure and thereby attempted to kill him, mean time his phone was taken and was beaten him till he discloses the password of such phone. Later he was shifted to Govt General Hospital the doctor Prabhavathi who treated him has issued false medical certificates at the instance of police officials. Additionally, PV Sunil Kumar threatened him that he will be killed if he were to criticize the then Chief Minister Mr. Y.S Jagan Mohan Reddy. Apart from the stated allegations, the complainant also noted so many serious, heinous nature allegations against several persons which are required to be investigated by the appropriate police authority


