ORDER:

In the G.O.1st read above, Government of Andhra Pradesh introduced "Electric Mobility Policy 2018-23" with a view to make Andhra Pradesh one of the major hubs for electric mobility. The Policy aims to support every aspect of Electric Mobility and accelerating adoption of electric vehicles that eventually lead to healthier climate. In the G.O. 2nd read above, Government provided incentives by way of exemption of registration fee and tax on electric motor vehicles to the individuals / Government, including Undertakings, Corporations. Organizations, Urban and Rural bodies for purchase / lease and use towards demand creation.

2. Keeping in view of the Electric Mobility policy, Government vide references 3rd, 4th read above, exempted from payment of tax in respect of motor vehicles operated with batteries or ultra capacitors or fuel cells and registered on or before 07th June, 2023.

- 3. In the G.O. 7th read above, Government have extended the A.P. Electric Mobility Policy 2018-23 for further six months or till the new Electric Mobility Policy is promulgated whichever is earlier.
- 4. In the G.O. 8th read above, Government have exempted from payment of tax payable under the APMVT Act 1963 in respect of motor vehicles operated with batteries or ultra capacitors or fuel cells and registered from 01.02.2024 to 07.07.2024 or until the new Electric Mobility Policy is promulgated whichever is earlier.
- 5. In the G.O. 9th read above, Government have extended the A.P. Electric Mobility Policy 2018-23 from 08.06.2024 for further six months or till the new Electric Mobility Policy is promulgated whichever is earlier. Hence, the Government have decided to extend the exemption from payment of tax in respect of motor vehicles operated with batteries or ultra capacitors or fuel cells.
- 6. The following Notification will be published in an Extra-Ordinary issue of Andhra Pradesh Gazette dated: 10.10.2024.

NOTIFICATION

In exercise of the powers conferred by Clause (a) (ii) of Sub-Section (1) of Section 9 of the Andhra Pradesh Motor Vehicles Taxation Act, 1963 (Act 5 of 1963), the Governor of Andhra Pradesh hereby grants exemption from payment of tax payable under the APMVT Act 1963 in respect of motor vehicles operated with batteries or ultra capacitors or fuel cells and registered from 08.07.2024 to 07.12.2024 or until the new Electric Mobility Policy is promulgated whichever is earlier.
