INSTRUCTIONS TO CANDIDATES:

- 1. Fee for Regular candidates for all subjects is Rs.125/-
- 2. Fee for upto three and less than 3 subjects is Rs.110/-
- 3. Fee for more than 3 subjects is Rs.125/
- 4. Fee for Vocational candidates is Rs.60/- in addition to Regular Examination fee of Rs.125/- prescribed for SSC academic courses.
- 5. The candidates belonging to Scheduled Castes / Scheduled Tribes and Backward Classes who are appearing for SSC Public Examinations March-2025 for the first time as Regular candidates and whose parental income does not exceed Rs.24, 000/-per annum in urban areas and Rs.20,000/- or land holding not exceeding 2.5 Acres wet land / 5 acres dry land in Rural areas are exempted from the payment of examination fee. As such, the Headmasters are requested to satisfy themselves about the Parental income by insisting upon a certificate issued by the Mandal Revenue Officer as per rules.

- 2. Online application link will be available in office website www.bse.telangana.gov.in. The Headmasters / Principals has to login with their user Id and password.
