## NOTIFICATION

In exercise of the powers conferred by section 47 (1) of the Andhra Pradesh Excise Act, 1968, and in continuation to the orders issued in G.O.Ms.No.12, Revenue (Excise-II) Department, Dated:08.01.2018, the Government of Andhra Pradesh hereby specifies the following for compounding of offences:

- 1) The MRP violation committed by the Shop licensee for the first time may be compounded for Rs.5 Lakhs and for the second time the Shop license may be cancelled.
- 2) The offence of sale of liquor at a place (Belt Shops) other than the licensed premises committed by the Shop licensee for the first time may be compounded for Rs.5 Lakhs and for the second time, the Shop license may be cancelled.
- 3) The orders issued in GO Ms. No.12, Revenue (Excise-II) Department, dated 08-01-2018, may be applied for compounding the offences mentioned in Section 47 (1) of AP Excise Act, 1968 except MRP violations and running Belt Shops by Shop licensees. However, the offences committed by the Bar licensees be dealt with as per the proviso under Section 47 (1) of AP Excise Act, 1968.
