The brief facts of the case are that on 05.12.2024 at 04:00 hrs received a complaint from Sri Magudampalli Bhaskar S/o. Gundaiah (Late), Age: 40 yrs, Occ: Private Job, R/o. H. no. 16-11-511/160, 170, Shalivahana Nagar, Dilsukh Nagar, Hyderabad, Cell. No. 8019809201, in which he stated that his v fe Revathi, Age: 39 yrs, Occ: Housewife, R/o. H. no. 16-11-511/169, 170, Shalivahana Nagar, Dilsukh Nagar, Hyderabad. He has a son named Sri Tej, Age: 9 yrs and one daughter, Sanvika, Age: 8 yrs, they toge

her on 04.12.2024 , went to Pushpa II movie premiere show for watching, by taking the movie tickets, to the Sandhya 70 MM Theatre, at around 21.10 hours, by that time the theatre was filled with the crowd, at around 2140 hours, actor Allu Arjun, who is about to come to Sandhya 70 MM theatre, his personal security persons is removing the crowd from the theatre, My wife named Revathi and son Sai Tej, who were in the lower balcony hall, were unable to breathe and due to suffocation had fallen down, The police who were doing their duty had rescued them and shifted them to Durga Bai Deshmukh hospital for the treatment. By that time his wife is expired. His son after the First-Aid, he was shifted to KIMS, Hospital Begumpet for better treatment. Therefore, without any prior arrangements and facilities, by allowing the huge public into the theatre, which made us vacant the seats and they pushed down, and made wife death and my son, who got admitted in the hospital. The reason for the incident is because of Sandhya 70 MM Theatre management and the staff and the reason for the crowd pushed and surged forward because of the actor Allu Arjun and his personal security staff, he requested to take necessary action on them as per law.
