ORDER:

In the G.O. read above, Government have sanctioned (24) additional posts of Public Relations Officers on temporary basis, to work in the Peshi of the (24) Ministers @ one (1) PRO post in each Peshi of the Hon'ble Minister. Accordingly, Government is hereby issue the following guidelines for filling up of the posts of Public Relations Officer are as hereunder:

(i).Qualification:

- a. Must have passed Degree in any subject or an equivalent qualification.
- b. Degree/Diploma in Journalism or Public Relations (or) Five (5) years experience in Journalism.

(ii). Selection methodology:

Permission accorded to the Director, I&PR, A.P., to outsource the personnel (PROs) from the APCOS or any other reputed Manpower Supply Agency.

(iii).Terms and conditions of appointment:

These posts are purely on temporary basis and co-terminus with the tenure of the Minister or their need ceases, whichever is earlier and they will be appointed on deputation/outourcing method.

(iv). Remuneration:

Consolidated remuneration @ Rs.37,000/- per month. The remuneration shall be drawn and disbursed by the Departments concerned which are drawing the pay and allowances of the respective Ministers.

2. The Director, I&PR, A.P., Vijayawada shall take further necessary action accordingly.
